**EXPRESSION OF INTEREST (EOI)**

**1. Introduction**

Kerala State Handicapped Persons Welfare Corporation (KSHPWC), a Government of Kerala Public Sector Undertaking under the Department of Social Justice, invites **Expression of Interest (EOI)** from eligible and accredited agencies for undertaking **comprehensive renovation works** at its **Head Office in Thiruvananthapuram** in compliance with the norms laid down by the **Finance Department of Government of Kerala** for the execution of public works.

The work shall be executed in accordance with the procedures and norms outlined in G.O. (P) No. 104/2022/Fin. and as amended from time to time, including the selection of accredited agencies from the panel approved by the Government of Kerala.

**2. Scope of Work**

The proposed renovation work will include:

- Civil interior works (flooring, false ceiling, wall treatments, office partitioning)
- Electrical rewiring, lighting systems, and related fixtures
- Plumbing, sanitary upgrades, and water supply systems
- Accessibility enhancements in accordance with the Rights of Persons with Disabilities Act, 2016
- Modernization of restrooms and public spaces
- Repair and painting of the building façade and associated structural elements HVAC (Heating, Ventilation, and Air Conditioning) installation/upgrade.
- Detailed specifications and bill of quantities (BoQ) will be issued at the RFP stage.

**3. Eligibility Criteria**

EOIs are invited **only from agencies accredited by the Government of Kerala Finance Department** for execution of public works. Applicants must satisfy the following:

- Accredited as per the Finance Department guidelines (G.O. (P) No. 104/2022/Fin.)
- Valid registration with CPWD/Kerala PWD/Local Self Government institutions or equivalent
- Proven experience in handling similar public sector renovation works of a minimum of ₹10000 Lakhs in the last five years
- Statutory compliance (PAN, GST registration, EPF/ESI where applicable)
- Sufficient manpower and technical capability to execute the work within stipulated timelines
- Supporting documents must be provided as proof of eligibility and accreditation

#### 4. Documents to be Submitted

The Expression of Interest must be submitted along with the following documents:

- Cover letter indicating interest and confirmation of eligibility
- Copy of valid accreditation under G.O. (P) No. 104/2022/Fin.
- Company profile including organizational structure, technical staff, and key personnel
- Work experience including details of at least two(2) similar projects
- Copies of PAN, GST, and registration certificates
- Audited financial statements or CA-certified turnover for the past three financial years
- Any other document deemed necessary to support eligibility
