**EXPRESSION OF INTEREST (EOI)
FOR THE SUPPLY OF ASSISTIVE DEVICES FOR PERSONS WITH DISABILITIES**

1. INTRODUCTION

The Kerala State Handicapped Persons Welfare Corporation Ltd., a Government of Kerala Undertaking, is engaged in the implementation of various welfare schemes and initiatives for the empowerment and rehabilitation of persons with disabilities across the state. In pursuit of its objectives, the Corporation hereby invites **Expression of Interest (EOI)** from eligible and reputed manufacturers, authorized dealers, distributors, and suppliers for the **supply of assistive devices** to differently-abled persons under various government schemes and programs.

2. SCOPE OF WORK

The selected vendors will be required to supply, deliver, and, where necessary, demonstrate the use of assistive devices to eligible beneficiaries as per the specifications provided by the Corporation. The scope includes but is not limited to the following categories of assistive devices:

- Wheelchairs
- Artificial limbs and orthotic appliances
- Mobility aids (crutches, walking sticks, walkers)
- Visual aids and Braille devices
- Smart assistive technologies and accessible communication devices
- Any other devices as may be prescribed by the Corporation from time to time
- List Of Aids and Appliances Attaching

3. ELIGIBILITY CRITERIA

Interested parties must fulfill the following minimum eligibility conditions:

- The applicant must be a legal entity registered in Kerala with a minimum of **Two (2)** years of experience in the manufacture/supply of assistive devices.
- Service facilities should be made available in all districts in Kerala.
- Institutions should have at least 4 professional degree holders (BPO with valid RC registration). At least one of them must be female.
- Institutions will be subject to inspection by the Facility Technical Committee.
- Gait training required by the beneficiary for a specified number of days (Training) free of charge should be guaranteed by the institution
- The components in the equipment supplied by the institution should be CE certified
- Distribution of equipment should be done on a fixed date every month in the presence of the technical committee.
- The applicant must possess all necessary certifications relevant to the products offered (such as ISO, CE, BIS, etc.).
- The Institutions should have an administrative office.
- The applicant must have prior experience in executing similar assignments for government agencies, public sector undertakings, or reputed NGOs.

- The applicant must have valid PAN, GST registration, and comply with all applicable statutory requirements.
- The applicant should not have been blacklisted or debarred by any government or public body.

4. DOCUMENTS TO BE SUBMITTED

The Expression of Interest must be accompanied by the following documents:

- Cover letter expressing interest
- Company profile, including organizational structure and areas of operation
- Certificate of incorporation/registration
- Details and specifications of products offered, along with applicable certifications
- List of clients and past projects, especially with government or public sector entities
- Audited financial statements for the last three financial years
- Copy of PAN, GST registration, and other statutory registrations
- Declaration of non-blacklisting (self-attested)

Empanelled vendors may subsequently be invited to participate in a limited or open tender process for the final procurement. An expert team constituted by the Technical Committee will inspect the physical infrastructure and clinical facilities of the tenderer, in accordance with the norms and guidelines approved by the Technical Committee, prior to the award of the tender.
